- the right to reproduce or authorize its reproduction on paper or any other medium for the purposes of
 private use, for illustration in teaching or scientific research, insofar as is justified by the intended nonprofit motive;
- d. the right to adapt it for the purposes set out in points a, b and c above and to take any necessary steps for its technical archiving and preservation, as well as making it available to the end user, but without prejudice to the moral rights of the author of the WORK, in particular the right to respect for the integrity of the WORK.
